Title: Consider recommendations regarding agreements to provide crane, trucking, and street sweeping services, as follows:

Acting as the Board of Directors, Flood Control and Water Conservation District:

a) Approve and authorize the Chair to execute agreements for crane services for the period of July 1, 2023 through June 30, 2025, in the amount of not to exceed \$1,000,000.00 with each of the following contractors:

- i) T and T Trucking and Crane Service (a tri-county vendor); and
- ii) Big Red Crane Company, Inc. (a tri-county vendor);

b) Approve and authorize the Chair to execute agreements for trucking services for the period of July 1, 2023 through June 30, 2025, in the amount of not to exceed \$2,000,000.00 with each of the following contractors:

- i) Bob's Backhoe and Trucking (a local vendor);
- ii) RLF Trucking and Grading Corp (a local vendor); and
- iii) Speed's Oil Tool Service, Inc. (a local vendor)

c) Approve and authorize the Chair to execute agreements for street sweeping services for the period of July 1, 2023 through June 30, 2025, in the amount of not to exceed \$1,000,000.00 with each of the following contractors:

- i) Surface Management Inc. DBA WaterWorks (a local vendor);
- ii) SCA of CA, LLC (a tri-county vendor); and
- iii) Spadaro Enterprises, Inc. (not a local vendor); and

d) Find that the recommended actions to award contracts for crane, trucking, and street sweeping services are fiscal activities not constituting a "Project" within the meaning of the California Environmental Quality Act, as set forth in 14 CCR 15378(b)(4).
