- i) Bob’s Backhoe and Trucking (a local vendor);
- ii) Lash Construction, Inc. (a local vendor); and
- iii) Granite Construction, Inc. (a local vendor); and

c) Find that the recommended actions to amend contracts for trucking and maintenance services are fiscal activities not constituting a “Project” within the meaning of the California Environmental Quality Act, as set forth in 14 CCR 15378(b)(4).
