ii) As to funding of the "S.T.A.R. Complex SB 1022" Project included in the Recommended FY 2015-2016 Capital Projects Budget on Page E-14 and D-411;

c) Delegate authority to the County Executive Officer to execute renewal of single-year grants and contracts ("ongoing grants and contracts") included in the Recommended Budget that had previously been approved by the Board, where contract amounts are up to 10% greater or less than previously contracted amounts;

d) Adopt the Resolution of the Board of Supervisors entitled In the Matter of Adopting the Budget for FY 2015-2016; and

e) Determine pursuant to California Environmental Quality Act (CEQA) Guidelines section 15378 that the above activities are not a project under CEQA.
