a) Approve and authorize the Public Health Director to execute the Third Amendment to Agreement No. 12-89329 with the California Department of Health Care Services, Cancer Detection and Treatment Branch, for the Public Health Department to provide regional administrative services for the period January 1, 2012 through December 31, 2016 for an amount not to exceed \$1,654,400.00;

b) Approve Budget Revision Request No. 0003726 reflecting \$46,800.00 of unanticipated revenue for Fiscal Year 2014-2015 from the Department of Health Care Services and increasing Services and Supplies in the County's financial system; and

c) Determine that these activities are exempt from California Environmental Quality Act (CEQA) review per CEQA Guideline Section 15378(b)(4), since the recommended actions are government fiscal activities which do not involve commitment to any specific project which may result in a potentially significant physical impact on the environment.
