	vii) Adopt a Resolution establishing an appropriation limit for FY 2015-2016 for the Santa Barbara County Flood Control and Water Conservation Districts;		
	c) Select the change in the California Per Capita Personal Income as the price factor in determining the Fiscal Year 2015-2016 limit for Santa Barbara County, and the California Per Capita Personal Income for special districts, and ratify selections by recorded vote; and		
	d) Select the change in population within Santa Barbara County and all contiguous counties as the population factor in determining the Fiscal Year 2015-2016 limit for Santa Barbara County, and the change in population within Santa Barbara County for the special districts and ratify selections by recorded vote.
