Title:	<p>Consider recommendations regarding Fiscal Year (FY) 2015-2016 Alcohol and Drug Program (ADP) Non-Perinatal Intensive Outpatient Treatment Services Amendments and Budget Revision Request, as follows: (4/5 Vote Required)</p> <p>a) Approve and authorize the Chair to execute a First Amendment for Services of Independent Contractor with Good Samaritan Shelter Inc., (a local vendor), to add Non-Perinatal Intensive Outpatient Treatment Services, and to increase the contract amount by \$50,000.00 for a maximum contract amount not to exceed \$1,879,729.00 through June 30, 2016;</p> <p>b) Approve and authorize the Chair to execute a First Amendment for Services of Independent Contractor with Mental Health Systems, Inc. (a local vendor), to add Non-Perinatal Intensive Outpatient Treatment Services, and to increase the contract amount by \$125,000.00 for a maximum contract amount not to exceed \$1,120,481.00 through June 30, 2016;</p> <p>c) Approve and authorize the Chair to execute a First Amendment for Services of Independent Contractor with Sanctuary Psychiatric Centers (a local vendor), to add Non-Perinatal Intensive Outpatient Treatment Services, and to increase the contract amount by \$75,000.00 for a maximum contract amount not to exceed \$279,790.00 through June 30, 2016;</p> <p>d) Approve Budget Revision Request No. 0004196 increasing appropriations of \$250,000.00 FY 2015 -2016 in the Alcohol, Drug and Mental Health Services (ADMHS) Department, Alcohol and Drug Programs Fund for Services and Supplies, funded by unanticipated revenue from Drug Medi-Cal; and</p> <p>e) Determine that the above actions are government fiscal activities or funding mechanisms which do not involve any commitment to any specific project which may result in a potentially significant impact on the environment, and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA guidelines.</p>
