| <b>Title:</b>         | Consider recommendations regarding Amendments for Animal Services City Agreements for Fiscal Year 2016-2018, as follows:<br><br>a) Approve, authorize, and ratify a Fifth Amendment to the Agreement with the City of Buellton to provide animal control services for the period of July 1, 2016 through June 30, 2018 for a total amount of \$75,986.00 for the two year period;<br><br>b) Approve, authorize, and ratify a Fourth Amendment to the Agreement with the City of Santa Barbara to provide animal sheltering services for the period of July 1, 2016 through June 30, 2018 for a total amount of \$756,122.00 for the two year period;<br><br>c) Approve, authorize, and ratify a Fifth Amendment to the Agreement with the City of Solvang to provide animal control services for the period of July 1, 2016 through June 30, 2018 for a total amount of \$84,585.00 for the two year period;<br><br>d) Approve, authorize, and ratify a Fourth Amendment to the Agreement with the Santa Ynez Band of Chumash Indians to provide animal control services for the period of July 1, 2016 through June 30, 2018 for a total amount of \$3,837.00 for the two year period; and<br><br>e) Determine that these activities are exempt from California Environmental Quality Act (CEQA) review per CEQA Guideline Section 15061(b)(3), since it can be seen with certainty that there is no possibility that the activities may have a significant effect on the environment. |                      |                      |
