a) Approve and authorize the Chair to execute a Sixth Amendment to the Agreement with the City of Buellton

to provide animal control services for the period of July 1, 2018 through June 30, 2020 for a total amount of \$80,477.00 for the two year period;

b) Approve and authorize the Chair to execute a Sixth Amendment to the Agreement with the City of Guadalupe to provide animal control services for the period of July 1, 2018 through June 30, 2020 for a total amount of \$117,591.00 for the two year period;

c) Approve and authorize the Chair to execute a Fifth Amendment to the Agreement with the City of Santa Maria to provide animal control services for the period of July 1, 2018 through June 30, 2020 for a total amount of \$1,577,539.00 for the two year period;

d) Approve and authorize the Chair to execute a Sixth Amendment to the Agreement with the City of Solvang to provide animal control services for the period of July 1, 2018 through June 30, 2020 for a total amount of \$89,585.00 for the two year period;

e) Approve and authorize the Chair to execute a Fifth Amendment to the Agreement with the Santa Ynez Band of Chumash Indians to provide animal control services for the period of July 1, 2018 through June 30, 2020 for a total amount of \$4,064.00 for the two year period; and
