- b) Receive and file a staff report on the Santa Barbara County HOME Consortium and Santa Barbara CDBG Urban County Partnership draft FY 2017-2018 Action Plan Substantial Amendment (Amendment);
- c) Consider public comments received on the draft Amendment and draft Action Plan during the thirty (30) day public comment period, which commenced on May 18, 2018 and concludes at the end of the Board's public hearing on these items on June 19, 2018;
- d) Consider and approve the recommendations for funding contained in the draft Action Plan and draft Amendment;

- g) Authorize the County Executive Officer or her designee to execute all certifications, standard forms and other related documents required for the acceptance and administration of CDBG and HOME funds and authorize the County Executive Officer or her designee to execute all certifications, standard forms, and other related documents required for the submittal to and approval by HUD of the Amendment and Action Plan; and
- h) Determine that the recommended actions are not the acceptance and approval of a project that is subject to environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(4), finding that the project is a creation of government funding mechanisms or other government fiscal activities, which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and direct staff to file a Notice of Exemption.
