iii) \$130,218.00 to People Assisting the Homeless (PATH) Santa Barbara for the PATH Santa Barbara Emergency Shelter project; and

iv) \$38,951.00 to United Way of Northern Santa Barbara County for the Coordinated Entry System; and

b) Determine that the recommended actions are not the acceptance and approval of a project that is subject to environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(4), finding that the project is a creation of government funding mechanisms or other government fiscal activities, which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment, and

direct staff to file a Notice of Exemption.
