b) Approve and authorize the Public Works Director, or designee, to approve Agreement amendments within the scope of work in an amount of not to exceed \$17,750.00 for a total Agreement amount not to exceed \$195,245.00;

c) Approve Budget Revision Request No. 0006081 increasing appropriations in the amount of \$195,245.00 in the South Coast Flood Zone for Services and Supplies releasing Restricted Fund Balance to fund costs for this agreement; and

d) Find that the recommended action to award a contract for environmental services is a fiscal and administrative activity not constituting a "Project" within the meaning of the California Environmental Quality Act, as set forth in 14CCR 15378(b)(4) and (5).
