- iii) Romero Creek Debris Basin Improvement Project in the not-to-exceed amount of \$325,840.00;
- b) Approve and authorize the Public Works Director, or designee, to approve Agreement amendments within the scope of work for:
- i) Cold Spring Debris Basin in the amount of \$31,824.00 for a total Agreement amount of not-to-exceed \$350,064.00;
- ii) San Ysidro Debris Basin in the amount of \$31,824.00 to a total Agreement amount of not-to-exceed \$350,064.00; and
- iii) Romero Creek Debris Basin in the amount of \$32,584.00 for a total Agreement amount of not to exceed \$358,424.00; and
- c) Find that the recommended action to award contracts for engineering services, is a fiscal and administrative activity not constituting a "Project" within the meaning of the California Environmental Quality Act, as set forth in 14CCR 15378(b)(4) and (5).
