	d) Approve and authorize the Chair to execute a CDBG Subrecipient Agreement in the amount of \$30,043.00 between the County and People Assisting the Homeless (PATH);						
	e) Approve and authorize the Chair to execute a CDBG Subrecipient Agreement in the amount of \$350,000.00 between the County and Good Samaritan Shelter;						
	 f) Approve and authorize the Chair to execute a CDBG Subrecipient Agreement in the amount of \$114,194.00 between the County and Alpha Resource Center (ARC); g) Approve and authorize the Chair to execute a CDBG Subrecipient Agreement in the amount of \$60,000.00 between the County and Child Abuse Listening and Mediation (CALM); h) Approve and authorize the Chair to execute a CDBG Subrecipient Agreement in the amount of \$40,000.00 between the County and Habitat for Humanity; i) Approve and authorize the Chair to execute a CDBG Subrecipient Agreement in the amount of \$40,000.00 between the County and Habitat for Humanity;
