<b>Title:</b>	<p>Consider recommendations regarding the renewal of the Sheriff Office's Military Equipment Use Ordinance, as follows:</p> <p>a) Set a hearing for May 2, 2023 to consider the introduction (First Reading) of an Ordinance to re-adopt and amend the Santa Barbara County Sheriff's Office Military Equipment Use Policy; and (Set a hearing for May 2, 2023. Time estimate: 30 minutes)</p> <p>b) Determine that the activity is not a "Project" subject to California Environmental Quality Act (CEQA) review per CEQA Guideline Section 15378(b)(5), since the activity is an organizational or administrative activity of government that will not result in direct or indirect physical changes in the environment;</p> <p>On May 2, 2023, consider recommendations, as follows:</p> <p>i) Receive and file a presentation regarding an Ordinance re-adopting the Santa Barbara County Sheriff's Office Military Equipment Use Policy;</p> <p>ii) Receive and file the annual military equipment report;</p> <p>iii) Consider and approve the introduction (First Reading) of an Ordinance to re-adopt and amend the Santa Barbara County Sheriff's Office Military Equipment Use Policy;</p> <p>iv) Read the title of the Ordinance and waive full reading of the Ordinance;</p> <p>v) Determine that the activity is not a "Project" subject to California Environmental Quality Act (CEQA) review per CEQA Guideline Section 15378(b)(5), since the activity is an organizational or administrative activity of government that will not result in direct or indirect physical changes in the environment; and</p> <p>vi) Continue the item to the Administrative Agenda of May 9, 2023 to consider the adoption (Second Reading) of an Ordinance adopting the Military Equipment Use Policy, as follows:</p> <p>1) Consider and approve the adoption of the Ordinance (Second Reading) to re-adopt and amend the Santa Barbara County Sheriff's Office Military Equipment Use Policy; and</p> <p>2) Determine that the activity is not a "Project" subject to CEQA review per CEQA Guideline Section 15378(b)(5), since the activity is an organizational or administrative activity of government that will not result in direct or indirect physical changes in the environment.</p>
